Disclosure & Disqualification Requirements

Any person or group of persons acting in concert who directly or indirectly contribute \$1,000 or more in support of or in opposition to a change of organization or reorganization that has been submitted to Modoc LAFCO must comply with the disclosure requirements of the Political Reform Act of 1974 applicable to local initiative measures to be submitted to the electorate. These requirements contain provisions for making disclosures of contributions and expenditures at specified intervals; they may be reviewed at Government Code §§56700.1 and 81000 et seq. Additional information about the requirements pertaining to local initiative measures to be presented to the electorate can be obtained by calling the Fair Political Practices Commission at (916) 322-5660. A LAFCO Commissioner must disqualify herself or himself from voting on an application involving an "entitlement for use" (such as an annexation or sphere amendment) if, within the last twelve months, the Commissioner has received \$250 or more in campaign contributions from the applicant, any financially interested person who actively supports or opposes the application, or an agency (such as an attorney, engineer, or planning consultant) representing the applicant or an interested party. The law (Government Code Section 84308) also requires any applicant or other participant in a LAFCO proceeding to disclose the contribution amount and name of the recipient Commissioner on the official record of the proceeding. Local Agency Formation Commission of Modoc County Meeting Minutes August 9, 2022

1. Call to order / Pledge of Allegiance

Vice Chair Cheryl Nelson called the meeting to order at 4:00 p.m. at the City Council Chambers located at 200 W. North Street in Alturas, CA and via Zoom. Commissioner Rhoads, Commissioner Coe, Commissioner Neer, Commissioner Minchella, Commissioner Crosby, and Vice Chair Nelson were present. Commissioner Byrne was absent. Public attending 2.

Staff Present: John Benoit, Executive Officer, and Macey Binning, Clerk.

2. Election of the Chair and Vice-Chair for FY 2022-2023

Commissioner Coe made the motion to elect Kathie Rhoads as Chair; seconded by Commissioner Minchella. In favor were Commissioners Rhoads, Neer, Coe, Minchella and Vice Chair Nelson.

Motion passed unanimous.

Commissioner Coe made the motion to elect Marie Neer as Vice Chair; seconded by Commissioner Minchella. In favor were Commissioners Nelson, Neer, Coe, Minchella and Chair Rhoads.

Motion passed unanimous.

3. Approval of the Agenda (Additions and Deletions)

Commissioner Coe made the motion to approve the agenda as presented; seconded by Commissioner Nelson. In favor were Commissioners Nelson, Neer, Coe, Minchella and Chair Rhoads.

Motion passed unanimous.

4. Correspondence

Executive Officer Benoit reports he has a few items to pass to Commissioner Minchella regarding the CALAFCo annual conference that Commissioner Minchella will be attending in October.

5. Consider Minutes for the June 14, 2022 LAFCO meeting

Commissioner Nelson made the motion to approve the June 14, 2022 LAFCo minutes; seconded by Commissioner Neer. In favor were Commissioners Nelson, Neer, Coe, Minchella and Chair Rhoads.

Motion passed unanimous.

6. Public Comment - None

7. Consent Agenda

Commissioner Coe made the motion to adopt the consent agenda as follows: a.) Authorize the payment claims for June 2022 and July 2022; b.) Approve **Resolution #2022-0009** authorizing a remote teleconference meeting; seconded by Commissioner Nelson. In favor were Commissioners Nelson, Neer, Coe, Minchella and Chair Rhoads.

Motion passed unanimous.

8. Workshop regarding LAFCo Bylaws review and update

Executive Officer Benoit stated the LAFCo bylaws have not been updated in fifteen years. Mr. Benoit reviewed the LAFCo bylaws and has made changes to update accordingly. Mr. Benoit reviewed the changes with the Commissioners to ensure the Commissioners agreed with the changes and asked if the Commissioners had any suggestions.

Commissioner Coe suggests instead of having the reimbursement for travel per diem amounts in the bylaws to adopt through a policy so it can be amended annually if needed.

Commissioner Neer informed Mr. Benoit of a typographical error on page 32. Indefinitely was misspelled in the records retention chart.

9. Executive Officer's Report

Executive Officer Benoit informs the Commissioners he is currently working with Modoc County Assistant County Administrative Officer Tiffany Martinez on the Likely Water District. Mr. Benoit was under the impression that this District was dissolved. During their research they discovered the Likely Water District is still active and in the past they requested dissolution. However, the Commissioners denied this request. The Likely Water District is not active, but Mr. Benoit was approached by the Railroad requesting to dispose of the current water system.

Modoc County Administrative Officer Chester Robertson asked Mr. Benoit if the Likely Fire District inquired about annexation.

Mr. Benoit replied that they did. However, Mr. Benoit has not responded and wanted to bring this to the Commissioners attention first.

Modoc County Administrative Officer Chester Robertson informed the Commissioner he was recently made aware of a dispute regarding the existing water tank located in Likely, CA. Lassen Railroad Trust was maintaining and treating the water for consumption. However, a majority of this tank is used for fire protection. Lassen Railroad Trust has initiated litigation requesting backpay for the years of treating the water tank. They claim there isn't a legal agreement stating Lassen Railroad Trust is responsible for maintaining the tank. Currently, only three residential properties and one commercial property are connected to the water tank. A few of the property owners are willing to walk away from their properties because the cost of a lawsuit is more than the value of the property. Likely Fire District is interested in the tank for fire protection but not maintaining the water system. This issue will come before the Modoc LAFCo once a solution has been determined to satisfy all parties involved. However, Mr. Robertson is researching all his options before proposing any solutions. Mr. Robertson would like to see all Likely Districts merge into one district.

Executive Officer Benoit believes a solution is possible. The Likely Fire District could assume the water tower but it can only be for fire protection not a drinking water system. However, Mr. Benoit would like to resolve the Likely Water District. It might beneficial for Likely Water District to become an association and provide the services. The disadvantage would be as an association they could not apply for grants. Mr. Benoit will add this to next meetings agenda to discuss further.

Commissioner Coe would like to see a representative from the Likely Fire District attend the LAFCo meeting when they discuss the options.

Executive Officer Benoit reports the Canby Community Service District and Canby Fire District are going to meet regarding consolidation. Executive Officer Benoit informs the Commissioners the Senate Bill 938 Hertzberg has been signed by the Governor and is changing the LAFCo protest process. The past protest threshold was 10% and now will increase to 25%. This takes effect January 1, 2023.

10. Commissioners Reports - Discussion

Commissioner Coe notifies Mr. Benoit Modoc County has a new Board of Supervisor Shane Starr for District 2. Mr. Starr will be assuming the County alternate position on the Modoc County LAFCo Board replacing Gyri Byrne. Commissioner Coe was approached by an individual from Tionesta, CA regarding expansion of the Tulelake Fire District Boundaries. Mr. Coe asks Mr. Benoit if he can research and inform Mr. Coe of the procedures.

11. Adjourn to the next regular meeting on October 11, 2022

There being no further business to come before the Commission. Motion made by Commissioner Coe to adjourn at 5:29 p.m.; seconded by Commissioner Nelson. In favor were Commissioners Nelson, Neer, Coe, Minchella and Chair Rhoads. Motion passed unanimous.

RESOLUTION NO. 2022-0010

A RESOLUTION OF MODOC LAFCO AUTHORIZING A REMOTE TELECONFERENCE MEETING OF THE COMMISSION PURSUANT TO GOVERNMENT CODE SECTION 54953(e)

WHEREAS, Government Code section 54953(e), as amended by Assembly Bill No. 361, allows legislative bodies to hold open meetings by teleconference without reference to otherwise applicable requirements in Government Code section 54953(b)(3), so long as the legislative body complies with certain requirements, there exists a declared state of emergency, and one of the following circumstances is met:

- 1. State or local officials have imposed or recommended measures to promote social distancing.
- 2. The legislative body is holding the meeting for the purpose of determining, by majority vote, whether as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees.
- 3. The legislative body has determined, by majority vote, pursuant to reason two below, that, as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees.

WHEREAS, the Governor of California proclaimed a state of emergency pursuant to Government Code section 8625 on March 4, 2020; and

WHEREAS, the MODOC LAFCO desires to hold its public meetings by teleconference consistent with Government Code section 54953(e).

NOW, THEREFORE, MODOC LAFCO DOES HEREBY RESOLVE AS FOLLOWS:

Section 1. <u>Recitals</u>. The Recitals set forth above are true and correct and are incorporated into this Resolution by this reference.

Section 2. <u>Conditions are Met</u>. The MODOC LAFCO hereby finds and declares the following, as required by Government Code section 54953(e)(3):

- 1. The Governor of California proclaimed a state of emergency on March 4, 2020, pursuant to Government Code section 8625, which remains in effect.
- 2. The reasons for adopting this resolution are one or more of the following:
 - a. State or local officials have imposed or recommended measures to promote social distancing.

- b. The legislative body is holding the meeting for the purpose of determining whether as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees.
- c. The legislative body has determined that, as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees.

2022 Local Agency Biennial Notice

Government code section 87300 et. seq. (the Political Reform Act) requires each local government agency to keep a conflict of interest code and update it to reflect changes that occur in the organization of an entity. The Local Agency Formation Commission (as well as other local agencies) is required to review and amend its Conflict of Interest code on even-numbered years. A biennial notice is normally sent out by the County Clerk or other official designated by the Board of Supervisors during the summer of even numbered years to each agency required to review its Conflict of Interest Code. After review or approval of the Conflict of Interest Code LAFCO is required to submit any proposed changes to the Board of Supervisors acting as the code reviewing body.

Government code section 87311 requires review of a conflict of interest code to be carried out under procedures which guarantee to officers, employees, members and consultants of the agency and to residents of the County adequate notice and a fair opportunity to present their views. A notice of Public Hearing was initially published prior to LAFCO adopting its conflict of interest code on December 12, 2006. Prior to 2006 LAFCO's last Conflict of Interest code was adopted in 1995. The Modoc Co. Board of Supervisor's, acting as the Code Reviewing Body, approved LAFCO's conflict of interest code on January 16, 2007 and adopted Resolution 2007-02.

Recommendation:

Authorize the Chair to sign and transmit the 2022 Local Agency Biennial Notice to the County Clerk (or person designated by the Board of Supervisors) declaring LAFCO has reviewed its Conflict of Interest code and no amendment is required at this time.

WHEREAS, the Board of Supervisors serves as the conflict of interest code reviewing body for the County of MODOC; and

WHEREAS, Government Code §87303 requires the Board of Supervisors to approve, revise and approve, or return for revision and resubmission each conflict of interest code adopted by a local agency; and

WHEREAS, the Local Agency Formation Commission of Modoc County adopted a standard conflict of interest code and appendix designating Commission Members to disclose at Categories 1,2,3,4,5, and 6; the Executive Officer to disclose at Categories 1,2,3,4,5, and 6; and Consultants at Categories 1,2,3,4,5, and 6 thereto, a copy of which is attached as Exhibit A;

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors adopts the standard Conflict of Interest Code and Appendix thereto adopted by the Local Agency Formation Commission of Modoc County Resolution 2006-0004.

WHEREAS, the Political Reform Act, Government Code section 81000, et seq. requires state and local government agencies to adopt conflict of interest codes; and

WHEREAS, the Fair Political Practices Commission has adopted a regulation, Title 2, California Administrative Code, Section 18730, which contains the terms of a standard conflict of interest code; and

BE IT RESOLVED the COMMISSION of the LOCAL AGENCY FORMATION COMMISSION of Modoc County hereby adopts the Fair Political Practices Commission's standard Conflict of Interest Code as described in the attached regulations contained in Title 2, California Administrative Code, Section 18730, and the attached appendix in which employees are designated and disclosure categories are set forth, subject to approval by the Board of Supervisors of the County of Modoc.

BE IT FURTHER RESOLVED, that the Conflict of Interest Code and attached appendix shall be submitted to the Board of Supervisors of the County of Modoc for approval and that upon approval, the Conflict of Interest Code and attached appendix shall be deemed adopted and shall be promulgated by the LOCAL AGENCY FORMATION COMMISSION of Modoc County.

BE IT FURTHER RESOLVED that the standard code adopted hereby and subject to approval by the Board of Supervisors of the County of Modoc constitutes the Conflict of Interest Code of the LOCAL AGENCY FORMATION COMMISSION of Modoc County, and pursuant to Section 4(a) of the standard code, designated employees shall file original statements of economic interests with the Modoc County Clerk.

BE IT FURTHER RESOLVED that prior conflict of interest codes previously adopted by the <u>LOCAL AGENCY FORMATION COMMISSION of Modoc County</u> are hereby repealed and replaced by the standard code.

*Consultants shall be included in the list of designated employees and shall disclose pursuant to the broadest disclosure category in the Code subjected to the following limitation:

The Executive Officer may determine in writing that a particular consultant, although a "designated position", is hired to perform a range of duties that is limited in scope and thus is not required to fully comply with the disclosure requirements described in this section. Such written determination shall include a description of the consultant's duties and based upon that description, a statement of the extent of disclosure requirements. The Executive Officer's determination is a public record and shall be retained for public inspection in the same manner and location as this Conflict of Interest Code.

Category 1

Persons in this category shall disclose all interests in real property within the jurisdiction. Real property shall be deemed to be within the jurisdiction if the property or any part of it is located within or not more than two miles outside the boundaries of the jurisdiction or within two miles of any land owned or used by the local government agency.

Persons shall not be required to disclose property used primarily as their residence or for personal recreational purposes.

Category 2

Persons in this category shall disclose all investments.

"Investment" means any financial interest in or security issued by a business entity, including but not limited to common stock, preferred stock, rights, warrants, options, debt instruments and any partnership or other ownership interest owned directly, indirectly or beneficially by the public official, or other filer, or his or her immediate family, if the business entity or any parent, subsidiary or otherwise related business entity has an interest in real property in the jurisdiction, or does business or plans to do business in the jurisdiction, or has done business within the jurisdiction at any time during the two years prior to the time any statement or other action is required under this title. No asset shall

be deemed an investment unless its fair market value equals or exceeds two thousand dollars (\$2,000). The term "investment" does not include a time or demand deposit in a financial institution, shares in a credit union, any insurance policy, interest in a diversified mutual fund registered with the Securities and Exchange Commission under the Investment Company Act of 1940 or a common trust fund which is created pursuant to Section 1564 of the Financial Code, or any bond or other debt instrument issued by any government or government agency. Investments of an individual includes a pro rata share of investments of any business entity, mutual fund, or trust in which the individual or immediate family owns, directly, indirectly or beneficially, a 10-percent interest or greater. 'The term "parent, subsidiary or otherwise related business entity" shall be specifically defined by regulations of the commission. (Government Code Section 82034).

Category 3

Persons in this category shall disclose all income received from any source located or doing business within the jurisdiction or expecting to do business within the jurisdiction. Income received from a public agency need not be disclosed.

Category 4

Persons in this category shall disclose all income from and investments in businesses that provide or sell services or supplies of the type associated with job assignment and utilized by the department.

Category 5

Persons in this category shall disclose all business positions held in business entities which are located or doing or expecting to do business within the jurisdiction and which business entities may foreseeably be affected materially by any decision made or participated in by the person by virtue of his or her position. "Business entity" as used herein includes both for-profit and non-profit entities.

Category 6

Persons in this category shall disclose all items (including real property) valued over \$360.00 received as a gift, purchased from, or sold to any person applying for or receiving any services from the Department;

The above Categories 1 through 6 shall comply with the Form 700 disclosure filing requirements.
